This repeater is a simplex repeater with store and resend software in the modem at the transceiver. This call sign is CAM-RLY. The repeater is on the Milam County Communication Tower and uses the same antenna as the 147.020 repeater. That antenna is a db224 with 6db gain. It is approximately 150 feet AGL.
